Indeed, sustainable best practices are key to business survival and long-term resilience.

We have witnessed technological advancements, increased government regulations, rising consumer preference for sustainable products and a global commitment to a low-carbon future. These trends serve as a clarion call for business leaders to re-examine their business models and transform their operations to become more responsible and sustainable. From environmental impacts to social and governance changes, it is imperative for businesses to anticipate and respond to a diverse range of sustainability-related risks and opportunities.

At CDL, we have remained steadfast in maintaining our global leadership as a green developer. Amongst many others, CDL was once again ranked the world's top real estate company and top Singapore company on Corporate Knights' 2021 Global 100 Most Sustainable Corporations in the World, making us the longest listed Singapore company on the Global 100 list for 12 consecutive years since 2010. In addition, CDL is one of few companies globally that has been recognised on both the 2020 CDP A List for corporate climate action and for water security, making us the only Singapore company to score an A in 2020 and the only company in Southeast Asia and Hong Kong to remain listed on the CDP A List for three consecutive years. We were also selected as one of the world's 50 Sustainability & Climate Leaders hosted by Bloomberg—a clear reflection of our position as an ESG pioneer that has been driving transformative change and climate action for over two decades.

10 DECEMBER 2020 – CDL held its 7th Annual Sustainability Forum for the Hong Leong and CDL Group of companies at Distrii Singapore Auditorium, Republic Plaza. As we continue to face devastating disruptions caused by global climate and health crises, there is a greater need for corporates to review their business model to achieve long-term sustainability and resilience.

Around 85 directors, senior management, and staff of the CDL and parent company Hong Leong Group's companies attended the forum—some in person, while others virtually via Zoom. The forum served as a dynamic platform for various ESG and sustainable finance experts to share their insights on how ESG integration can enhance business resilience and sustain long term growth in the new normal.



To minimise contact between people and ensure social distancing, on-site attendees were seated 1-metre apart from one another. The forum was also broadcasted via Zoom for virtual attendees.

The distinguished panel of speakers included keynote speaker Dr Lawrence Loh, Director of Centre for Governance and Sustainability, National University of Singapore Business School; Mr Shinbo Won, Director of Investment Stewardship at BlackRock; Ms Chitra Hepburn, Head of APAC ESG Client Coverage at MSCI and Ms Yulanda Chung, Head of Sustainability at DBS.

The forum kicked off with an opening presentation by CDL Chief Sustainability Officer Ms Esther An, who set the scene by underscoring the climate emergency and discussing the impact of COVID-19 on global ESG trends. She also shared CDL's sustainability journey since 1995 and how it has helped the company build business resilience, create stakeholder value and adapt to new global challenges.


Dr Loh then took the stage to deliver his keynote address, focussing on how ESG integration and reporting raises the brand value of businesses. Citing his academic research that establishes the positive relation between sustainability disclosure and brand value, he shared the intricacies of his study and

highlighted CDL as a strong business case for sustainability.

The presentations were followed by a lively and insightful panel discussion that comprised all the invited speakers, moderated by Ms An. The highly engaged audience sought strategic and practical advice from the esteemed panel, who shared their unique perspectives from their diverse industries and sectors on global sustainability trends and provided a holistic view on the topic. Their discussion reinforced the message that ESG issues have indeed become key considerations in business, investment and financing decision making process.

In the closing remarks by CDL Group Chief Executive Officer Mr Sherman Kwek, he emphasised the importance of adopting innovative sustainability strategies for a more resilient future, as ESG integration and investing have become mainstream in the fast-changing and challenging business environment.

Co-organised by the Group Corporate Secretariat Services and CDL's Sustainability department since 2014, the annual forum aims to keep the Group's directors and senior management abreast of the latest sustainability trends and best practices. •

The SIPF is a biennial event that serves as a platform to discover, nurture and empower Southeast Asian photographers to enter the global stage. Gathering minds from all around the world with the common purpose of advancing the arts and the appreciation of photography, SIPF strives to engage the public and cultivate a larger audience through its associate programmes, such as SYPA.

The only national award for Singapore photographers between the ages of 13 and 25, SYPA was initiated by CDL and spearheaded by the late CDL Deputy Chairman, Mr Kwek Leng Joo. Born from his love of photography and belief in youth development, SYPA was implemented in 2005 in celebration of Singapore's 40th Birthday and aims to promote the art of photography

and developing promising artistic talents.

This year's theme for the 8th edition of CDL's SYPA was "ZERO", which called on contestants to rethink climaterelated problems and how we should change to achieve a more sustainable future. Issues that were up for exploration included zero waste, zero energy and zero marine pollution, and they had to connect to the UN SDG 7 (Affordable and Clean Energy), 11 (Sustainable Cities and Communities), 12 (Responsible Consumption and Production), 13 (Climate Action), 14 (Life Below Water), and 15 (Life on Land).

Two grand winners and four merits recipients received cash prizes totalling S\$10,000 for their outstanding contributions and creative takes on sustainable development and urban landscapes. A heartfelt congratulations to the winner of the Junior Category, Kate Lu, Merit winners Jomel Goh and Janson Lim; the winner of the Youth Category, Hamizah Saini, and Merit winners Lisa Peh and Jovin Lee! •

In the spirit of giving, individuals, companies and embassies donated to the Gardens and decorated trees throughout the Gardens. Schools, hospitals and non-profit organisations also participated in this initiative,

decorating their respective trees with a special message of hope and inspiration.

All proceeds went towards the Gardens' <u>Give to the Gardens programme</u>. Initiated in 2016, this programme supports the Garden's work as a prominent botanical institution and contributes to the conservation of Singapore's local and regional flora while inspiring a love for nature and environmental protection amongst the community.
