Asia Sustainability Report of the Year 2021 Overall Winner: 4 Golds & 1 Bronze



CDL continues to make headway in our sustainability journey: we were recognised as a top performer on several benchmarks including Asia Sustainability Reporting Awards, the inaugural FT-Nikkei Climate Leaders Asia Pacific 2022 Award, Equileap Gender Equality Award, SGBC-BCA Leadership in Sustainability Awards and SpeakIn Asia Dialogue: Asia's Top 10 ESG Leaders. We also launched the second edition of our Climate Action Exhibition entitled 'Change the Present, Save the Ocean' at the CDL Green Gallery, graced by special guest Dr Sylvia Earle.

This quarter saw the unabated momentum of urgent calls for climate action. From commemorating Earth Day on 22 April to World Environment Day on 5 June, individuals, communities, civil society, businesses, and governments around the world continued rallying for expedited change. This year's Earth Day was a call to "Invest in Our Planet" while World Environment Day reinforced the importance of #OnlyOneEarth. As the window for the world to reach net zero by 2030 becomes smaller, living sustainably in harmony with nature requires everyone to take action.

In April 2022, CDL exemplified this spirit of collaborative action through the second instalment of our climate action exhibition titled 'Change the Present, Save the Ocean.' The exhibition was jointly organised by CDL, the National Parks Board and Ocean Geographic, to highlight the ocean crisis and global commitments to marine conservation. Post COP26, this ocean-themed exhibition was a timely reminder that urgent climate action across different sectors and countries is critical to spearhead real change.

With global calls to go net zero, companies are under pressure to be more sustainable. Measurement and disclosure of a company's sustainability performance continue to be fundamental in business management, as companies cannot manage what they do not measure. Since our first sustainability report issued in 2008, CDL has been communicating and reporting our ESG data. Today, our reporting model has evolved into a unique blend of GRI Standards as our core, supplemented by CDP, GRESB, Integrated Reporting Framework, the UN SDGs, TCFD, SASB and CDSB. As a testament to our sustainability reporting rigour, CDL was conferred Asia's Report of the Year, a special award for its Integrated Sustainability Report (ISR) 2021, at the Asia Sustainability Reporting Awards (ASRA). Recognised by one of the most prestigious international awards for corporate sustainability reporting, CDL was honoured to be the only Singapore company that received the highest number of gold awards this year. CDL will continue to set a high bar for quality ESG reporting towards our ESG goals and targets.

As a further testament to our unwavering commitment to sustainable development, CDL emerged as a top performer in Equileap's gender equality report and was also recognised for significant contributions to Singapore's built environment sector at the biennial Leadership in Sustainability Awards 2022 co-organised by the Singapore Green Building Council and Building and Construction Authority.

On 13 June 2022, CDL was also recognised as the only Singapore property company to be listed in the inaugural edition of FT-Nikkei Climate Leaders Asia Pacific 2022 award. Out of 200 companies, we were the only Singapore property company to be listed.

Businesses increasingly recognise the opportunities available in the circular, low-carbon economy of the future. Many have made a head start in harnessing sustainability as a competitive advantage. There are now more than 5,000 companies worldwide in the UN Race To Zero campaign, of which CDL is one of the Singapore companies to make this commitment a reality. The Glasgow Financial Alliance for Net Zero mobilised over US\$120 trillion of private capital to catalyse the transformation of the global economy towards net zero emissions by 2050.

In this decade of action, it is imperative for businesses to understand the irrevocable interconnection between profit and purpose. To attain business resilience in the long-run, corporate leaders should take ownership of how truly integrating sustainability in their business strategies will unlock value for greener growth. As we accelerate action in the global charge towards a net zero future, CDL will continue to strengthen our focus on ESG, and explore pathways towards a greener world for all.

Asia Sustainability Reporting Awards

CDL wins top accolade and highest number of gold awards for sustainability reporting

6 APRIL 2022 – CDL was conferred Asia's Report of the Year special award along with four golds and one bronze, at the Asia Sustainability Reporting Awards (ASRA) for its Integrated Sustainability Report (ISR) 2021. In its 7th year, ASRA is the most prestigious international awards for corporate sustainability reporting. Recognising the best-in-class sustainability reports around the region, CDL emerged as the only Singapore company to bag the greatest number of gold awards this year, clinching gold for Asia's Best Sustainability Report (Large Company), Asia's Best Sustainability Report (CEO Letter), Asia's Best Materiality Reporting, and Asia's Best Climate Reporting, and bronze for Asia's Best Sustainability Report (Governance) at the virtual awards ceremony held on 4 April 2022.

The awards follow a rigorous multi-tier evaluation process involving three assessment rounds to select the best in each category. An independent judging panel determines the finalists and winners. In addition to assessing the report quality, the judging process involves comprehensive due diligence that considers companies' reputation among their stakeholders. Amongst the international panel of judges are experienced sustainability reporting experts such as Dr Lawrence Loh, Director of Centre for Governance and Sustainability, National University of Singapore, and



Elaine Cohen, an expert voice in the field of sustainability strategy and reporting. •

FT-Nikkei Climate Leaders Asia Pacific 2022 Award

CDL recognised in the inaugural edition of FT-Nikkei Climate Leaders Asia Pacific 2022



13 JUNE 2022 – The Asia-Pacific region has been feeling the effects of global warming, from 2019-2020's bushfires to flash floods in central China last year and this year's floods in Australia. The countries on the FT-Nikkei Asia-Pacific Climate Leaders list are thus located in a region where the risks posed by climate change are especially acute.

CDL is honoured to be recognised in the inaugural edition of the FT-Nikkei Climate Leaders Asia-Pacific 2022, which identifies companies in the region that achieved the greatest reduction in their Scope 1 and 2

greenhouse gas (GHG) emissions intensity between 2015 and 2020. Out of 200 companies, CDL was the only Singapore property company to be listed. Other Singapore companies that were also recognised include Hong Leong Asia, Keppel Corporation (Construction and Building Materials), and Flex (Consulting and Professional Services).

Of the 200 companies listed, the biggest cut in emissions intensity was achieved by Bank Australia, a customer-owned financial services provider in Australia.

In terms of sectors, though, technology & electronics was the best represented in the list with 29 companies, followed by financial services with 21 companies.

Japan was home to the most companies listed, with 86, followed by Australia, with 47, and India, with 20. ●

Equileap's Gender Equality in Asia-Pacific Special Report 2022

CDL recognised as the top-rated company in Singapore for gender equality at work.



16 JUNE 2022 – CDL has emerged top in Singapore for gender equality at work based on research findings published in Equileap's dedicated Gender Equality in Asia-Pacific (APAC) Special Report 2022 Edition commissioned by Sasakawa Peace Foundation. This affirms its commitment to diversity and inclusion at the workplace. Focused on APAC's key developed economies, the report provides a status update on gender equality in businesses across the region,

offering key insights per market and sectors on specific issues ranging from gender pay gap to paid parental leave policies. In 2021, CDL was ranked top amongst Singapore companies on the Equileap Gender Equality 2021 Global Report and Ranking.

Headquartered in Amsterdam, Equileap is the leading organisation providing data and insights on gender equality in the corporate sector. The APAC special report covers Australia, Hong Kong, Japan, New Zealand and Singapore, and examined 1,181 publicly listed companies, representing 23 million employees. Assessed on 19 gender equality criteria such as gender balance from the board to the workforce and policies relating to anti-sexual harassment, amongst others, the report analyses research done in 2021. •

Successful Completion of ISO 14001 and ISO 45001 Surveillance Audits with Zero Non-Conformity

An audit for Corporate Office, Project development and Asset Management operations.

30 & 31 MAY 2022 - In lieu of ISO 14001 and 45001 surveillance audits, the CDL EHS management system underwent a review with revised interim 2022 sustainability targets (covering energy, emissions, water and waste). The CDL Future Value 2030 Sustainability Blueprint, first established in 2017, was updated in line with CDL's revised Science Based Targets Initiative (SBTi) targets. More stringent targets were validated in December 2021, effecting change in baseline year for several targets to 2016. Revised interim FY2022 targets reflecting projected 2030 Scope 1, 2 and 3 targets approved by SBTi were communicated and endorsed at the annual management review meeting with CDL Group CEO Mr Sherman Kwek and Heads of Departments.

Following the management review meeting, the CDL EHS team successfully completed the ISO 14001 and ISO 45001 surveillance audits. Document samples provided by corporate office, projects and asset management were reviewed. Site visits conducted on selected premises were found to be satisfactory with the EHS management system effectively established, implemented and maintained.

Four opportunities for improvement were identified for internal audit procedures, asset level EHS related internal communication; Permit to Work (PTW) and monitoring and measurement table. •

Singapore Green Building Council-Building and Construction Authority (SBGC-BCA) Leadership in Sustainability Awards 2022

South Beach and Singapore Sustainability Academy (SSA) recognised out of 20 awardees, for contributions and significant achievements in the development of a green and sustainable built environment in Singapore.



20 MAY 2022 – The biennial Awards programme, first held in 2017, honours significant achievements by individuals, organisations and project teams in the development of a green and sustainable built environment. After a pause in 2021, the Awards programme was refreshed for relaunch in 2022 with new award sub-categories to better reflect contemporary trends and developments as well as to uncover the impact of sustainability achievement from the industry.

The new outcome-based award sub-categories for Building Project Leadership in Sustainability - namely Carbon Performance, Community Engagement, Health & Wellbeing, Intelligent Building and Urban Renewal - are intended to celebrate outstanding building projects that push the boundaries of built environment sustainability. Using the top-tier BCA Green Mark Platinum certification rating as a minimum requirement

for consideration, the sub-categories allowed award applicants to better profile, highlight and convey the unique traits of their building projects.

More than 40 applications across all award categories were received and the main jury – comprising senior leaders from SGBC and BCA – commended the quality of the high-calibre applications received this year. •



SpeakIn Asia Dialogues: Top 10 ESG Thought Leaders in Asia

CDL's Chief Sustainability Officer (CSO), Ms Esther An, was honoured as one of Asia's Top 10 ESG Thought Leaders at the second edition of the SpeakIn Asia Dialogues' series.

21 JUNE 2022 — CDL CSO, Ms Esther An, has been recognised as one of Asia's Top 10 ESG Thought Leaders by SpeakIn "for being an ardent advocate of the environmental, social and governance principles underlying sustainability."

One of the key platforms through which Esther shares her thought leadership in climate action is CDL's Singapore Sustainability Academy (SSA). A hub for networking, the SSA enables industries, youths and the community to share knowledge and build partnerships, with more than 630 events and trainings conducted since its inception in 2017. The academy is the first ground-up initiative and zero-energy academy in Singapore dedicated to capacity building and collaboration. It has hosted more than 22,700 friends, trainees and partner organisations both locally and globally.

This unwavering spirit of bringing people together for progressive discussions on issues important for people and the planet, was underpinned in the closing statement of Esther's acceptance speech that "no single

person can save the world alone. Let us continue to work together to collectively create a sustainable and more resilient future for all". •

Opening of "Change the Present, Save the Ocean" Exhibition

This exhibition reinforces collaborative efforts between private and public sectors in support of global and national climate goals.



10 & 11 APRIL 2022 – In partnership with National Parks Board (NParks) and Ocean Geographic, a marine-themed publication, CDL launched an exhibition themed "Change the Present, Save the Ocean" on marine conservation. Running until December 2022 at the net zero CDL Green Gallery located in the Singapore Botanic Gardens, the exhibition amplifies the call for action to support both global and national climate efforts. It also showcases Singapore's commitment towards coastal and marine conservation as the nation continues transforming into a City in Nature.

The two-day launch event kick-started on 10 April 2022 with a "Keep Calm and Love our Planet: Save our Ocean" edition, with a preview tour of the climate action exhibition along with the launch of CDL's E-Generation Challenge 2022. The winner of the challenge will embark on a once-in-a-lifetime dream

excursion on the Antarctic Climate Epic Expedition in February 2023 with 110 eco-champions and create solutions to tackle the climate emergency.

The youth-focused event was jointly hosted by Singapore Youth for Climate Action, CDL, NParks and Ocean Geographic, in line with CDL's belief that youths can change the future.

Attendees were inspired to turn eco-anxiety into ecoaction through an engaging sharing by world-renowned marine biologist Dr Sylvia Earle and an exciting conversation with ocean conservation warriors:

- Sam Shu Qin; a coral scientist actively involved in restoring coral reefs in Singapore and Southeast Asia

As part of our sustainability engagement and outreach efforts with internal CDL stakeholders, Department Heads and key business executives took part in a sharing session with Dr Sylvia Earle on the role of businesses in advocating for marine conservation, followed by a pre-launch exhibition preview on the morning of 11 April 2022.

The exhibition was officially launched by Mr Desmond Lee, Minister for National Development in Singapore, on 11 April 2022. The opening ceremony was also graced by special guest Dr Sylvia Earle, who is also the Chair of the Ocean Geographic's Honorary Editors Board. Dr Earle inspired many in the audience to take action through her fireside chat about "Care for the Ocean".

Leveraging contactless displays, the exhibition takes visitors across four zones:

1. <u>Global Action:</u> Protecting the Ocean, Our Life Source — spotlighting COP26 and global efforts across sectors to conserve and sustainably use the ocean, seas and marine resources for sustainable development

The exhibition also features collaborations with global and local partners in climate action, including the Asia Pacific Real Estate Association, C40 Cities, Net Zero Alliance, United National Global Compact Network Singapore, and World Green Building Council.

Sustainable Fashion 2.0: The Great Reveal

In support of SDG 12 on responsible consumption and disposal, the event unveiled The Fashion Pulpit's survey findings on sustainable fashion and launched an exhibition on upcycled outfits.



10 JUNE 2022 – The fashion industry accounts for up to 10% of global carbon dioxide output – more than international flights and shipping combined – and accounts for a fifth of the 300 million tonnes of plastic produced globally each year ¹. "Sustainable Fashion 2.0: The Great Reveal", examines how we can be better wearers of our clothes to support SDG 12 on responsible consumption and disposal.

Hosted at the Singapore Sustainability Academy, the event kicked off with opening remarks from CDL CSO Ms Esther An, followed by a presentation by The Fashion Pulpit Founder Mr Raye Padit on the results of the "Inside Our Wardrobe: An Experiential Wardrobe Exercise" survey. Launched last November in conjunction with "Sustainable Fashion 2.0: Greening Our Wardrobe", this public survey invited participants to explore their consumption habits; at the same time the initiative aims to inspire the community to reflect on their consumption patterns, review the contents of their wardrobe and renew the relationship they have with their clothes, towards reducing the amount of waste going into our landfills.

The session also featured a lively panel discussion on sustainable fashion with eco-champions Ms Jasmine Tuan, Founder of Cloop; Ms Samantha Thian, Founder of Seastainable Co., and Ms Kae Hana, Fashion Lecturer and Biomaterial Researcher, moderated by Ms Xingyun Shen, Research and Impact Coordinator of The Fashion Pulpit.

Attended by 75 guests, the event was well-received with participants engaging in a thought-provoking Q&A session at the end of the panel discussion.

As part of the event, CDL also launched an exhibition at Level 3 of City Square Mall that showcases the upcycled clothing items worn by the eco-advocates during the "Sustainable Fashion 2.0: Greening Our Wardrobe" fashion show.

Through community engagement and empowerment programmes, we hope to bring the People, Public and Private sectors together to tackle the typical 'take, use and dispose' linear approach to consumption and spark discussions on the environmental impacts of fashion. •

Other than encouraging family bonding through storytelling and home video production, the contest, themed 'City in Nature', aims to unearth and develop young eco-champions and by extension their families, to strengthen their love of nature and inspire them to take action to protect our planet. The contest also seeks to continue My Tree House's education programmes while it is closed for renovation, using both physical and digital platforms.



To support those participating in the contest, CDL and NLB also organised an eco-storytelling workshop,

"Storytelling @ Central Public Library", on 8 June 2022. Hosted by Ms Lisa Zulkifli, Early Literacy Associate Librarian, the event featured a storytelling demonstration and tips by Ms Zulkifli and closed with a sharing segment by 2021 contest winners: Kimberlyn Chia, winner of the Preschool category; Nelini Chandrasiri, winner of the Upper Primary category; and Team Planet Earth Angels, under the Family category, which comprised Mrs Dorothy and her two daughters, Faith and Olivia.

Participants can submit their videos online, and those with the most inspiring messages on lessons learned from the stories and aspirations to protect the planet will be featured in a commemorative video. As COVID-19 restrictions have eased substantially, this year's edition of the contest will also feature a component where top finalists can present their storytelling inperson at our Singapore Sustainability Academy to a panel of judges.

CDL has always believed that the youths of today can shape the world of tomorrow. Through initiatives like these, we hope that the world will hear our children's love for our planet and work to create a greener, cleaner, and safer future for all. •
