

Editor's Note

The last quarter of 2023 continued the worrying trend of climate-related catastrophes, impacting world economies, nature and human lives. The festive season was disrupted by heavy snowstorms in the northern hemisphere, glacial lake outburst in the Himalayas and a super typhoon in the Philippines.

In Singapore, the city-state experienced heavy thundery showers that resulted in a 13.1% increase in its average annual total rainfall. 2023 is also Singapore's fourthwarmest year on record, setting the stage for what is projected to be the hottest year globally. In his opening address at the 28th UN Climate Change Conference (COP28), held in Dubai in November 2023, United Nations Secretary-General António Guterres said, "2023 will be the hottest year recorded in human history. The world is living through climate collapse in real time and the temperature record should send shivers down the spines of world leaders." These events signal the urgency to act on climate change and protect nature.

COP28 marked the conclusion of the first global stock take under the Paris Agreement. During the event, CDL maintained its leading position in thought leadership and collaboration, convening industry experts, government representatives, and NGOs to explore pathways towards a more sustainable future at home and abroad including at COP28 in Dubai.

I participated in numerous high-level panel discussions and events hosted by esteemed partners such as WEF, WGBC, Microsoft, SG Pavilion, GRI, GCNS, and Saint-Gobain underscoring CDL's influential presence at the conference.

As a testament to CDL's commitment towards good ESG practices, we were awarded the best ESG risk ratings award in acknowledgement of our exceptional efforts in sustainable business strategy in the annual The Edge Singapore Billion Dollar Club (BDC) Award category. CDL was also the winner of the Best ESG Reporting (Mid-Cap) Award at the prestigious IR Magazine Forum and Awards in Southeast Asia, which recognises our success in meeting shareholders' and investors' demands for transparency and credibility in ESG reporting. In December, we also secured the OCBC 1.5°C loan of £200 million (approximately S\$338.2 million), Singapore's first net zero-aligned loan for corporates to drive the transition to a low-carbon economy. This complements CDL's pioneering and innovative approach to mobilising sustainable finance to accelerate decarbonisation and green building since issuing the first green bond by a Singapore company in 2017.

As we wrap up 2023, we see the world caught in a pressing race against time to tackle threats caused by climate change and the loss of biodiversity. In the year ahead, CDL will remain steadfast in our commitment to our ethos of 'conserving as we construct' since 1995 and together with our value chain to create a positive impact on the planet and people.

The Edge Singapore BDC recognises excellence in companies listed on the Singapore Exchange (SGX), with at least S\$ 1 billion in market capitalisation. The billion-dollar cutoff serves as an aspirational target for dynamic, smaller companies. The awards started in 2017 and the assessment criteria focuses on SGX-listed companies' financial performance, profits, and growth. Winners in the BDC are those with a market cap that is above S\$1 billion while the Centurion Club recognises companies with a market value of between S\$100 million and S\$1 billion. Beyond prestige, this recognition offers valuable insights and credible testaments of each company to readers of The Edge Singapore in their investment decisions. •

It also focuses on environmental aspects such as air quality, water quality, thermal comfort, lighting and user experience to ensure that buildings promote a healthy and supportive environment for occupants.

Accorded to buildings that meet specific criteria, the WELL HSR incorporates strategies to help keep spaces clean and sanitised, provide essential health benefits and services, communicate health and safety efforts, prepare for an emergency, as well as assess air and water quality. •

26 October 2023 - With more than 600 ESG frameworks and standards around the world, it is essential yet challenging for global efforts to establish a baseline reporting standard. Given the ongoing reporting changes and new regulatory requirements, the reconciliation of reporting standards remains an onerous and gargantuan task for most corporates.

Held at the Ridley Hall at Singapore Botanic Gardens, the 10th Hong Leong-CDL Group Annual Sustainability Forum aimed to provide clarity and insights for company directors and management to be better prepared for the upcoming standards and regulations on climate reporting in their organisations. The forum was opportune with the global launch of IFRS S1 (General Requirements for Disclosure of Sustainability-related Financial Information), and S2 (Climate-related Disclosures) standards as an effort to reduce fragmentation of frameworks and signals that reporting is moving towards a more unified criterion.

Themed Sustainability Reporting - Value vs Investment; Challenges vs Opportunities, this is the first in-person forum in three years since the COVID-19 pandemic. More than 70 directors, senior management and staff of the Hong Leong and CDL Group of Companies were treated to presentations and insights of subject experts from two key regulators, SGX and ACRA, as well as leading ESG consultants who are savvy in reporting and climate governance. Moderated by CDL's CSO, Ms Esther An, who also chairs the Sustainability Reporting Advisory Committee on the national level, the dynamic discussion covers key ESG issues including global trends in mandating sustainability reporting, climate governance and corporate stewardship, transition planning, role of regulators in supporting companies as well as managing of institutional investors to push the sustainability agenda.

In his closing remark, CDL Group CEO Mr Sherman Kwek, emphasised the importance of collaborative partnerships in driving climate action, stressing that the more action taken now, the more pain we save ourselves in the future. He added that sustainability reporting will help companies identify gaps in their businesses and serve as a tool to adapt and mitigate risks, seize suitable opportunities and propel organisations forward in the journey towards net-zero.

To wrap up the forum, attendees were invited to the adjacent CDL Green Gallery for a tour of the Climate Action Exhibition, themed "Melting Ice, Sinking Cities: An Urgency to Change the Present and Save Humanity", which was opened earlier this year. •
