Editor's Note

As we pass the halfway mark of 2024, it's clear that our global environment is facing unprecedented challenges and opportunities. This period has been marked by a series of striking developments that highlight the urgency of innovation and collaboration in addressing climate and sustainability issues.

The world is experiencing a cascade of extreme weather events, with heat waves becoming alarmingly frequent and intense. Recently, Saudi Arabia faced a devastating heat wave that resulted in the tragic loss of over 1,300 lives in Mecca as temperatures soared above 51.8°C.¹ This tragedy underscores a troubling trend: longer and hotter heat waves significantly heighten the risks of non-accidental deaths. Such events are a stark reminder of the pressing need for robust climate action and adaptive strategies.

In Europe, the political landscape has shifted rightward, leading many to doubt the EU's commitment to ambitious environmental policies. Yet, in a surprising and hopeful development, the European Union (EU)'s environment ministers approved a landmark nature restoration law in May.² This bold initiative aims to restore 20% of EU land and

sea areas by 2030 and all ecosystems in need of restoration by 2050, setting a significant precedent for environmental stewardship and resilience.

On a global scale, the International Sustainability Standards Board (ISSB) has made notable strides. Currently, over half of the world's economy has adopted its sustainability standards.³ These standards were designed to streamline and harmonise sustainability and ESG disclosures, simplifying the reporting landscape and enhancing transparency.

Closer to home, the Asia-Pacific region, which houses two-thirds of the global population, is grappling with severe water stress and land degradation.⁴ Despite its rich biodiversity, this region faces accelerating droughts driven by population growth, rapid industrialisation, unmanaged urbanisation, and climate change. Urban areas, where the majority of people reside, are particularly vulnerable.

These challenges highlight the critical need for innovation and collaboration in building urban resilience. It is within this context that we recognise CDL's leadership and commitment to sustainability. CDL's active participation in the World Cities Summit reflects its dedication to addressing urban challenges and forging impactful partnerships. This platform allows CDL to engage with Government leaders and industry professionals to drive sustainable urban solutions.

CDL's achievements in sustainability have been further validated by recent accolades. The company was honoured with the Business Leadership in Sustainability Award (Impact sub-category) at the SGBC-BCA Leadership in Sustainability Awards 2024. For the second consecutive year, CDL was recognised by FT-Statista as one of the Asia-Pacific Climate Leaders for 2024. This recognition is based on significant reductions in Scope 1 and 2 greenhouse gas emissions intensity over the past five years, alongside transparency in Scope 3 emissions.

Additionally, CDL earned a spot on the TIME-Statista World's Most Sustainable Companies of 2024 list, ranking 46th – making it the highest-ranked Singaporean company. These accolades are a testament to CDL's unwavering commitment to integrating sustainability into its business model and creating a positive impact within the built environment sector and for its stakeholders.

As we continue to navigate these complex environmental and societal challenges, CDL remains resolute in its mission to drive sustainability and resilience through innovation and strategic collaboration. The road ahead may be fraught with difficulties, but with dedicated efforts and visionary leadership, we can make significant strides toward a more sustainable and resilient future.

CDL's CSO, Ms Esther An received the award on behalf of the company at the awards ceremony. 6 JUNE 2024 - CDL was conferred the Business Leadership in Sustainability Award (Impact sub-category) at the Singapore Green Building Council-Building and Construction Authority (SGBC-BCA) Leadership in Sustainability Awards 2024. CDL was recognised for the extensive outreach and impact created by the Singapore Sustainability Academy (SSA).

The SGBC-BCA Leadership in Sustainability Awards spotlights organisations that have meaningfully embraced sustainability into their business operations, products and solutions, and are beacons of sustainability leadership.

The 'Impact' category recognises organisations that have incorporated sustainability into their business models and contributed meaningful impact to the built environment sector and their stakeholders. •

CDL BAGS REGIONAL AND GLOBAL LISTINGS FOR BEING A LEADER IN SUSTAINABILITY



4 & 25 JUNE 2024 - For the second time, CDL has been recognised by FT-Statista as one of the Asia-Pacific Climate Leaders in 2024, along with 349 other companies. CDL received the same accolade in 2022's listing. Other Singapore companies included Keppel, Flex, ComfortDelGro, Frasers Property, Hong Leong Asia. As with previous years, the Climate Leaders list focuses primarily on companies that achieved the greatest reduction in their Scope 1 and 2 greenhouse gas (GHG) emissions intensity over a five-year period. Other factors are also considered, such as companies' transparency on Scope 3 emissions, which arise elsewhere in their value chains, and their collaboration with sustainability assessors, such as CDP and the Science Based Targets initiative (SBTi). These factors are assigned a score, which is combined with the reduction in emissions intensity figure to produce an overall total for each company. In 2022 and 2023, Japan dominated the list with 53.4% of companies this year. It was followed by Taiwan (11.4%) and Australia (10.9%). The best-performing sector was technology & electronics, with 20% of companies, followed by financial services, with 10.9%.

CDL was also proud to be recognised as one of TIME-Statista World's Most Sustainable Companies of 2024. CDL was ranked 46th, the highest ranked Singaporean company, with a score of 75.50. 1st place was given to Schneider Electric, at 88.86. NEC Corp (Japan), and Moncler (Italy) ranked 2nd and 3rd place respectively. Other Singapore companies included Keppel (187th), CapitaLand (223rd), ComfortDelGro (238th), Singtel (282nd), Flex (454th). The companies at the top of the list have signed on to some of the most respected climate programmes , including the 1.5°C target from the Science Based Targets initiative (SBTi), and receive high scores from CDP (formerly the Carbon Disclosure Project). TIME and Statista further held companies to high standards for their Scope 1 and 2 emissions and energy consumption relative to company size, emissions reductions in 2021 and 2022 (the most recent years fully reported), and proportion of renewable energy used by the company's operations. In 2024, a total of 500 companies were recognised globally.

CDL partnered DBS on first-of-its-kind TNFD targets-aligned sustainability-linked loan

S\$400 MILLION SUSTAINABILITY-LINKED LOAN WILL BE USED FOR GENERAL CORPORATE FUNDING AND WORKING CAPITAL PURPOSES



25 June 2024 - CDL has secured a S\$400 million landmark sustainability-linked loan provided by DBS Bank (DBS) to advance nature conservation and sustainable development in Singapore.

The loan is the first-of-its-kind, with criteria guided by the ambitious targets set by CDL in its adoption of the Taskforce on Nature-related Financial Disclosures (TNFD) Recommendations. CDL is the first company in Singapore to publish TNFD-aligned disclosures in its latest <u>Integrated Sustainability Report 2024</u>.

The TNFD targets aligned sustainability-linked loan is designed to incentivise CDL's ongoing efforts to achieve significant environmental, social, and governance (ESG) milestones. Proceeds will be used for general corporate funding and working capital purposes which include the redevelopment of CDL's existing assets. The loan incorporates specific performance targets related to biodiversity conservation and waste management, all of which are crucial components of the TNFD Recommendations.

To date, CDL has secured over S\$9 billion in sustainable financing in the form of a green bond, various green loans and sustainability-linked loans. •

SMEs with strong decarbonisation commitments and transparent data will have the opportunity to become preferred suppliers not only to CDL but also to other companies that are required to meet global carbon reporting standards and frameworks; such as CDP and the Science Based Targets initiative (SBTi). Participating SMEs can gain valuable knowledge and credibility for the data they collect through the program, as the framework for data collection is aligned with the requirements of CDP and SBTi.

Thanks to the efforts of key business units, CDL successfully collated and invited more than 150 SME suppliers to participate in the CDL SME Supplier Decarbonisation Queen Bee programme. On June 7, 2024, over 50 SMEs attended the first briefing session (Phase 1). The briefing session was jointly organised by CDL, GGC, and DBS, with attendance from Enterprise Singapore, CDP, and the Singapore Business Federation. The speakers at the session highlighted how SMEs can leverage the programme to enhance their sustainability capabilities, remain competitive, and explore new business opportunities. •

SSA Highlights: 1 April - 30 June 2024

The first-of-its-kind, it is a zero-energy facility dedicated to advancing the SDGs and climate action.

Despite the pandemic, the SSA has continued its mission by hosting a series of physical and hybrid sustainability talks. These sessions were free and open to the public, enabling the SSA to expand outreach beyond our shores. In Q2 2024, the SSA welcomed over 2,060 in-person attendees.

6 MAY 2024 - Climate and carbon reporting play pivotal roles in ensuring businesses, both listed and non-listed, large and small, accelerate transformation and amplify positive impact to tackle the climate emergency. Transparent and accurate reporting enables companies to measure, manage, and reduce their greenhouse gas emissions effectively. It is now a 'must-have' to foster accountability, enhance credibility, and to meet greater regulatory, investors, financiers, and consumers' expectations.

Companies that prioritise environmental performance, social responsibility, and good governance will be recognised by leading global ratings and rankings. The Corporate Knights' Global 100 ranking is considered the world's preeminent sustainability equity index and gold standard in corporate sustainability analysis. As a benchmark for best practices in sustainable business, the Global 100 serves as a catalyst for broader adoption of responsible business and sustainability reporting practices across industries.

Hosted at CDL's SSA, this session spotlighted Corporate Knights' CEO, Mr Toby Heaps for a roundtable discussion on the topic of carbon reporting and strategies for closing the climate gap. The event brought together key stakeholders and experts, including leaders from companies listed on the Global 100, to engage in critical dialogue on carbon and climate reporting, and towards closing the climate reporting, investing and policy gaps. •
